*The retreat on Financing for Development is intended to convoke an informal discussion among prospective direct participants in the Monterrey process and past participants (“alumni”) in the run-up to the High-level Dialogue on Financing for Development of the General Assembly in New York. The meeting is intended to focus on new and emerging issues and agenda items of the FfD debate rather than on procedural matters. The discussion will be in form of an unscripted and unrecorded dialogue (Chatham house rule) among about 35 participants that FES has invited in their personal capacity from governments in the North and South, multilateral institutions, civil society and the private sector.*

*Against this background, the objective of the retreat is to provide a space for in-depth discussions on the substantive issues of the FfD process, with a view for coming up with proposals that may help stakeholders prepare their participation in the Follow-up Conference on FfD in Doha, Qatar in 2008.*
