This session will turn to the roles of other actors in the UN system – in particular Treaty Bodies, OHCHR, and other UN agencies, with particular attention to the role of the ILO. What do the HRC's decisions in June 2011 and the SRSG's work mean for these actors in the time ahead? Examples in this session will include discussion of proposed new General Comments on the role of the corporate sector by CRC or CESCR. Another focus of the discussion might be on the activities of OHCHR in terms of capacity building at national level and within the UN system around the Guiding Principles and the UN "Protect, Respect and Remedy" Framework; and how ongoing initiatives by UN agencies should integrate the Framework into existing and planned programs and expand on its foundations over the coming years.

16:00 Business and Human Rights at National Level

Moderation: **Vijay Nagaraj (International Council on Human Rights Policy)**

Introductions: **Dwight Justice (International Trade Union Confederation)** and **Wambui Kimathi (Kenyan Human Rights Commission)**

This session will focus on how governments and other actors at national level – including NHRIs, companies, trade unions and civil society as well as other relevant mechanisms such as OECD contact points - will integrate the "Protect, Respect and Remedy" Framework and its Guiding Principles into national policies and legislation, how capacity and dissemination issues can best be addressed etc. Issues that might be discussed in this session include how governments assess and seek to reform current regulations concerning business to address human rights concerns and incentivize companies to report publicly on their social impacts including human rights. This session will also look at how trade unions can use the Guiding Principles and the UN Framework in their own dialogue with employers, how NHRIs address complaints involving companies, and how UN actors operating at national level can best provide support on issues relating to implementation of the Framework.

Questions for discussion may include: With the proliferation of initiatives, what is the best way forward for ensuring coherence and coordination? And how can the continued and increasing engagement by business be safeguarded and expanded? What role will trade unions and NGOs play in a multi-stakeholder approach?
