

Trade and decent work in Global Supply Chains

Information seminar for the FES-Asia project on “Core Labour Standards Plus”

5-11 June 2016 in Geneva, Switzerland

Trade liberalization and trade agreements in their current form have unleashed hyper-competitive pressure in products such as ready-made garments, footwear and consumer electronics. Social clauses linked to trade have provided little protection for workers on core labor standards, let alone safety, fair wages or social protection. However, there seems to be a window of opportunity to revive the old idea of a binding social clause in international trade and in global supply chains and combine it with a fair economic balance between suppliers, international companies, governments, trade unions and workers in Asia and Europe.

The FES-South East Asia “CLS Plus” project aims at developing a policy-oriented tool to assess and promote the implementation of comprehensive labour and social standards, including but also beyond the Core Labour Standards, in export-oriented industries in Asia in the framework of trade agreements and preference systems.

This Geneva based workshop will enable participants to get first-hand information from international experts of trade and labour rights’ policies. Additionally, participants will have the chance to further develop the regional project by incorporating the inputs received during this seminar.
