# NHRI roles with UPR 2<sup>nd</sup> cycle

- Unique role owing to unique status and functions under the Paris Principles
- Recognized role by GA and HRC resolutions
- Strengthened visibility of contributions: 1) separate section; 2) speaking slot immediately after the State under review; 3) video statements
- Expectations

## Preparing for the 2<sup>nd</sup> cycle

- Raise awareness about UPR outcomes and status of implementation of recommendations
- Synchronize internal work plans and reporting with UPR recommendations
- Organize post UPR discussions with government and civil society
- Monitor and report on the implementation of UPR outcomes

## **Raise awareness: Australian Human Rights Commission**

- UPR outcome: tabling of UN recommendations in Parliament
- AHRC briefing on UPR outcomes
- AHRC regular reports, including in annual reports
- Parliamentary awareness, public debate and engagement of stakeholders

# **NHRI internal work plans and reporting: South African Human Rights Commission**

- Mainstreaming UPR recommendations in the overall NHRI work
- UPR recommendations inform strategic planning and priority setting
- Allocation of UPR recommendations/monitoring with Commissioner or Committees
- SAHRC strategic plan provides that UPR recommendations will be tracked

# **Post UPR discussions: Kenya National Commission on Human Rights**

- Kenya NHRI and NGO coalition
- Kenya UPR Outcomes Charter with key expectations, indicators, actions and actors
- Objectives: 1) Record the understandings; 2) Propose a road-map; 3) Identify indicator-driven actions; 4) Establish monitoring framework

# **Monitor and report on implementation: Malaysia Human Rights Commission**

- Mid-term follow up report to HRC 18
- UPR recommendations clustered in 8 broad areas: 1) Ratification; 2) Legislative reforms; 3) Vulnerable groups; 4) ESC rights; 5) Trafficking in persons; 6) Education; 7) National strategies and policies; 8) Engagement with stakeholders
- Highlights advancements
- Stresses concerns, challenges and provides recommendations
- Discussed with State, UN SP & TB, NGOs, media

# Content of 2<sup>nd</sup> cycle report

- Identify key priorities
- Update on progress made
- Highlight challenges and formulate recommendations
- Tools and mechanisms; role of NHRI
- Include capacity assistance needs: ICC/OHCHR cooperation with UNCT and UNDP
- Non accepted recommendations?
